## CONDITIONS OF ENTRY

1. Entrance fees must be paid at time of entry.
2. Entries to be made through Secretary of entrant's Club to W.G.D.D. Captain, Mrs. Liz Gee, PO Box 75, SEYMOUR 3661.
3. The competition shall be played in accordance with the rules of golf adopted by the Royal and Ancient Club of St. Andrews, Scotland, together with such local rules as are in force on the course over which the competition takes place. (If a dispute arises on any point it shall be decided by the Dalhousie Match Committee, from whose decision any appeal shall lie with the Executive committee of G.V. provided same is lodged in writing through the Dalhousie Secretary within 7 (seven) days from date of such decision. The Executive Committee's decision on the matter shall be final.)
4. Any protest must be lodged in writing to the Dalhousie Match Committee before 6.00 pm on the day of which the disputed matter has arisen.
5. In every event competitors will be drawn against each other on the day in such a manner as the Match Committee decides.
6. The Match Committee is to make all arrangements and to have full power to alter or make variations to the conditions of the program, should they deem it desirable.
7. The Match Committee or such person as the Match Committee may authorise, may in the event of bad weather, or for any reason, either shorten the contest, or fix another day.
8. In the event of a tie or ties, the winners will be decided using the G.V. recommended countback format.
9. The Match Committee shall have the power to limit the number of entries which will be received in any event, and to alter the times fixed for starting any event in this program.
10. The attention of all entrants is directed to the necessity of complete accuracy in her entry form, and any entrant who is misrepresented will render herself liable to disqualification.
11. The G.V. standard conditions of entry, which includes accidents, drugs and personal risk, apply to all events.
12. No refunds after the closing date.
